





I have begun work on this request.

It asks in separate paragraphs for two things:

Calendar entries for two days.

This is easily provided. **2** documents. Minimal redaction will need to occur for non SES officers given titles of meetings that occur on those days.

2. "copy of any email or Teams entry of the Assistant Secretary Community Policy & Research made between 1 October 2023 and 10 February 2024 that has "DDVA HREC" or "HREC" in it".

In relation to this second matter, I reviewed all emails that I, as Assistant Secretary, Community Policy and Research, have sent between 1 October 2023 and 10 February 2024 that has "DDVA HREC" or "HREC" in it". There is a total of **72**.

I have reviewed all teams messages that I as Assistant Secretary, Community Policy and Research, have sent that has "DDVA HREC" or "HREC" in it" on the new Teams messages system. I do not have access to the previous teams system so that has not been searched. There is a total of **4**.

In relation to the **72** emails I am yet to isolate them into a separate folder or TRIM container. This means I have not yet counted the pages, and or documents attached to them. However, I assume this runs into hundreds of pages. Each of these documents is going to require careful consideration and much redaction. This a voluminous amount of work. I have set out examples of this redaction work below. In short, it would require me to manually go through every single document. This is many days of work.

I assume that the requestor, Jenny, is actually most interested in correspondence related to meetings of the DDVA HREC that involved the DVA MATES PROGRAM. This is because the DDVA HREC met on both of the dates that my copies of my calendar was requested and considered the DVA MATES PROGRAM. Given the amount of work that is involved by me, is it possible to raise this with Jenny and seek clarification if her request is about the DDVA HREC / DVA MATES PROGRAM and the scope can be limited to "DDVA HREC and DVA MATES PROGRAM".

Please advise.

Reasons for redaction include:

- Names of all staff that are not SES officers this would apply to all 78 initial documents referred to above + any documents attached to those emails.
- Commercial in confidence. Some of these emails are about payments to contracted consultants engaged by the Department to do research work (but do not include University of South Australia and are not related to DVA MATES Program).
- Sensitive information that involves the Minister's officer that is not related to DVA MATES Program.
- Sensitive information about other research projects not related to DVA MATES Program.
- Sensitive information concerning DDVA HREC: redactions are made to all sections and aspects that relate to any unapproved projects, and unresolved project matters, in line with the sensitivities identified below. This is the consistent with our requests my Branch has made in relation to similar FOI requests. The reasons for this are as follows:
 - O DDVA HREC members and proceedings are subject to strict confidentiality, as laid out in the letters of appointment and DDVA HREC Standard Operating Procedures (SOPs).
 - O DDVA HREC minutes only record the Committee's internal and confidential deliberations i.e., draft feedback and interim decisions.
 - Submissions and resubmission(s) of research proposals to DDVA HREC are the intellectual property of the applicant (researcher) and releasing the DDVA HREC's feedback on the submissions could cause reputational damage to external parties. Research projects are very specific and easily identified, and the Committee's concerns need to be addressed by the applicant before the project can proceed.
 - Approving the release of applicants' draft research may pose reputational risk to DVA, breaching trust, which may discourage researchers from undertaking future research contracts involving veterans and their families



I have reviewed all teams messages that I as Assistant Secretary, Community Policy and Research, have sent that has "DDVA HREC" or "HREC" in it" on the new Teams messages system. I do not have access to the previous teams system so that has not been searched. There is a total of **4**.

In relation to the **72** emails I am yet to isolate them into a separate folder or TRIM container. This means I have not yet counted the pages, and or documents attached to them. However, I assume this runs into hundreds of pages. Each of these documents is going to require careful consideration and much redaction. This a voluminous amount of work. I have set out examples of this redaction work below. In short, it would require me to manually go through every single document. This is many days of work.

I assume that the requestor, Jenny, is actually most interested in correspondence related to meetings of the DDVA HREC that involved the DVA MATES PROGRAM. This is because the DDVA HREC met on both of the dates that my copies of my calendar was requested and considered the DVA MATES PROGRAM.

Given the amount of work that is involved by me, is it possible to raise this with Jenny and seek clarification if her request is about the DDVA HREC / DVA MATES PROGRAM and the scope can be limited to "DDVA HREC and DVA MATES PROGRAM".

Please advise.

Reasons for redaction include:

- Names of all staff that are not SES officers this would apply to all 78 initial documents referred to above + any documents attached to those emails.
- Commercial in confidence. Some of these emails are about payments to contracted consultants engaged by the Department to do research work (but do not include University of South Australia and are not related to DVA MATES Program).
- Sensitive information that involves the Minister's officer that is not related to DVA MATES Program.
- Sensitive information about other research projects not related to DVA MATES Program.
- Sensitive information concerning DDVA HREC: redactions are made to all sections and aspects that relate to any unapproved projects, and unresolved project matters, in line with the sensitivities identified below. This is the consistent with our requests my Branch has made in relation to similar FOI requests. The reasons for this are as follows:
 - O DDVA HREC members and proceedings are subject to strict confidentiality, as laid out in the letters of appointment and DDVA HREC Standard Operating Procedures (SOPs).
 - O DDVA HREC minutes only record the Committee's internal and confidential deliberations i.e., draft feedback and interim decisions.
 - Submissions and resubmission(s) of research proposals to DDVA HREC are the intellectual property of the applicant (researcher) and releasing the DDVA HREC's feedback on the submissions could cause reputational damage to external parties. Research projects are very specific and easily identified, and the Committee's concerns need to be addressed by the applicant before the project can proceed.
 - Approving the release of applicants' draft research may pose reputational risk to DVA, breaching trust, which may discourage researchers from undertaking future research contracts involving veterans and their families





I thank you for your patience while we undertake this process and hope to be able to provide you with a decision on this matter shortly.


