As discussed, when we are discussing the rise in the unit price of delivering public hospital services, the best measure to use is the efficient annual growth in the National Efficient Price (NEP).

Each year, the IHACPA publishes a NEP Determination that sets the NEP for services to be delivered in that financial year. However, strictly speaking, the NEP for 2021-22 is not directly comparable to the NEP for 2022-23. Instead, the NEP for 2021-22 is the constructed average unit price for public hospital services as conceived of and classified in 2021-22. For 2022-23, public hospital services will be conceived of and classified in a different manner to they were in the prior year.

To allow comparability between years, the IHACPA engages in a process known as "back-casting" – that is, they seek to remove the changes in price caused by changed in classification, and instead have only the remaining real increases in price remain. This is known as efficient growth in the context of the NHRA, and is the basis upon which the Commonwealth's funding is calculated: we measure the growth between this year's "native" NEP, and last year's "back-cast" NEP.

Page 7 sets out the NEP for that year:

2.1 The national efficient price

The national efficient price (NEP) is \$5,797 per national weighted activity unit 2022–23 (NWAU(22)).

Page 27 sets out the back-cast prior year NEP for that year, and repeats the explanation I have just given as to why this is done:

11. **Back-casting**

Clause A41 of the Addendum to the National Health Reform Agreement 2020-25 (the Addendum) outlines that where the Pricing Authority makes any significant changes to the activity based funding (ABF) classification systems or costing methodologies, the effect of such changes must be back cast to the year prior to their implementation for the purpose of calculating Commonwealth funding estimates for each ABF service category.

In accordance with clauses A34(b) and A41 of the Addendum, the Pricing Authority has applied the methodological changes to the national efficient price for 2021-22 (NEP 2021-22) and determined the back-cast NEP 2021-22 for the purposes of determining Commonwealth growth funding estimated between 2021-22 and 2022-23 is \$5,567.

ear NEP c Hence, if we divide the 'native' 2022-23 NEP of \$5,797 by the "back-cast" prior year NEP of 2021-22 of \$5,567, we get an increase of 4.13%.
