## Freedom of information request no. 05-2025

  - "A copy of the Australia's Foreign Relations (State and Territory Arrangements) Act 2020 and the Australia's Foreign Relations (State and Territory Arrangements) (Consequential Amendments) Act 2020 as passed in full with signature of the Royal Assent (as well as, if there is any, signature/wording from the federal parliament or speaker)."

- I, Sue Pedder, Acting General Manager Corporate, am an officer authorised under subsection 23(1) of the FOI Act to make decisions in relation to FOI requests.

No particular form is required to apply for review although it will assist your case to set out in the application the grounds on which you believe that the original decision should be overturned.
