9. The NDIS Support Instrument is required to commence concurrently with the Amending Act as the NDIS cannot effectively operate without it. The Transitional Instrument is also required to commence with the Amending Act because it complements the NDIS Support Instrument and includes provisions to support the effective administration of the NDIS during the transition period.
