Re: Freedom of Information Request

I refer to your request received by the Department of Foreign Affairs and Trade (the department) for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

I am writing to provide you with a decision about your request.

I have identified a document relevant to your request. After careful consideration, I have decided to grant you access to the document in full.

Your request

On 18 October 2024, you made the following request:

- full powers for Australia's representative to sign the Treaty between Australia and the Kingdom of the Netherlands on the Presence of Australian Personnel in the Netherlands for the Purpose of Responding to the Downing of Malaysia Airlines Flight MH17 (signed on 1 August 2014),
- Memorandum of Understanding between the Australian Federal Police and the National Police of the Netherlands on Combating Transnational Crime and Developing Police Cooperation (came into effect on 2 June 2014, as mentioned in the above Treaty).

On 18 October 2024, you amended your request to the following:

- full powers for Australia's representative to sign the Treaty between Australia and the Kingdom of the Netherlands on the Presence of Australian Personnel in the Netherlands for the Purpose of Responding to the Downing of Malaysia Airlines Flight MH17 (signed on 1 August 2014)?"

What "full powers" refers to is a document that a head of state, a head of government, or the foreign minister, authorises someone else to conclude a treaty on the state's behalf.

Authority

I am an officer authorised under <u>section 23 of the FOI Act</u> to make decisions in relation to FOI requests.

Reasons

- the terms of your amended request;
- the document that falls within scope of your request;
