### Freedom of information request no. 25-2025

1 The purpose of this letter is to give you a decision about access to documents that you requested under the *Freedom of Information Act 1982 (FOI Act)*.

2 You requested access to documents relating to the *Statute Law Revision Act 2010*. Specifically, you sought access to:

- a) “A copy of the Act as passed with signature of the Royal Assent.”
- b) “Documents submitted to the Governor-General for royal assent to the Act (including the certificate from either the House of Representatives or the Senate, and the certificate signed by the Attorney-General recommending assent).”

3 The Office of Parliamentary Counsel (OPC) transferred the second part of your request to the Office of the Official Secretary to the Governor-General on 22 January 2025.

### *Decision and reasons for decision*

4 I, Stephen Campbell, General Manager Corporate, am an officer authorised under subsection 23(1) of the FOI Act to make decisions in relation to FOI requests.

5 In response to your request, a true copy of the Governor-General’s signature on the *Statute Law Revision Act 2010* is attached.

6 I have taken the following material into account in making my decision:

- The content of the documents that fall within scope of your request;

## ***Your review rights***

8 If you are dissatisfied with the information provided, you may apply for internal review or to the Information Commissioner for a review. We encourage you to seek internal review as a first step as it may provide a more rapid resolution of your concerns.

### **Internal review**

9 Under section 54 of the FOI Act, you may apply for an internal review of my decision. Your application must be made within 30 days after the date of this letter.

10 An internal review will be conducted by a different officer. No particular form is required to apply for review although it will assist your case to set out in the application the grounds on which you believe that the original decision should be overturned. An application for a review of the decision should be lodged in one of the following ways:

11 If you choose to seek an internal review, you will subsequently have a right to apply for Information Commissioner review of the internal review decision.

### **Information Commissioner review**

12 Under section 54L of the FOI Act, you may apply to the Australian Information Commissioner to review my decision. An application for review by the Information Commissioner must be made in writing within 60 days after the date of this letter, and be lodged in one of the following ways:
