# Freedom of Information (FOI) request - Access Decision

On 23 March 2021, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

## 1 Scope of request

You have requested access to the following documents:

I would like to request under the Freedom of Information Act any and all site assessments and/or records of site preparation works pertaining to the possibility of transferring or otherwise accommodating children of any age (including infants) in the Regional Processing Centre on Nauru from 2012-2018.

On 20 April 2021 the Department issued you a notice under section 24AB of the FOI Act. You responded via email and the following revised scope was agreed to:

'I would like to limit my request to site assessments pertaining to the possibility of transferring or otherwise accommodating children of any age (including infants) in the Regional Processing Centre on Nauru from 2012-2018. I would not need site assessments that were specifically designed for consideration of adult or staff needs'.

# 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

#### 3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from departmental officers with responsibility for matters relating to the documents to which you sought access

## 4 Documents in scope of request

The Department has undertaken reasonable searches in relation to the documents you have requested access to.

#### Searches

In summary, the following relevant business areas were contacted and confirmed via email that they do not hold any documents in scope:

- North and Immigration Detention Command
- Operational Coordination and Planning
- Regional Processing Contracts Branch

Having regard to your request and the types of documents that may fall within the scope of your request I am satisfied that the searches conducted were extremely thorough and all reasonable steps have been taken to locate any document relevant to your request.

#### 5 Decision

Section 24A of the FOI Act provides that the Department may refuse a request for access to a document if all reasonable steps have been taken to find the document and the Department is satisfied that the document does not exist.

I am satisfied that the Department has undertaken reasonable searches in relation to your request and that no documents were in the possession of the Department on 23 March 2021 when your FOI request was received. As such, I am refusing your request based on the application of section 24A of the FOI Act.
