Caveats

Note 1: In 2021, DVA adopted a new model for estimating average treatment card cost. Rather than considering all cards issued, this model uses Active Users, a measure of the quarterly exposure of card holders that have ever had health expenditure covered to date.

Note 2: The number of active Gold Card users in FY2020-21 may be slightly higher than total Gold Card holders as at June 2021 due to a shrinking population. Care should be taken when comparing these figures with previous years.

Note 3: War Widow(er)s include VEA War Widow(er) Pension recipients and MRCA Wholly Dependant Partners (WDP).

Note 4: Please note that some veteran Gold Card holders are also War Widow(er)s.
